ANTI-RAGGING: A MANDATORY COMPLIANCE

Ragging is a cognizable offence (offence for which the police can arrest the offender without warrant). According to the Honorable Supreme Court of India, ragging means: "Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student, or asking the students to do any actor perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student."

The Supreme Court has termed "RAGGING" as a Criminal Offence and is punishable under the court of law.

Thus, our motto is: Zero Tolerance to Ragging! A firm NO to ragging in any form!!

In view of the above, each student who got admission in the institution must require to compliance the Anti-Ragging directive as given by the Hon'ble Supreme

The step wise procedure for ANTI RAGGING COMPLIANCE is as under:

- 1) Click link https://antiragging.in/affidavit_registration_disclaimer.html
- 2) Click Tab "AFFILIATED COLLEGE"

- 9) Prof. (Dr.) R.R. Panda (Proctor) will keep hard copy of Affidavit and Undertaking in record for future reference.


